### 01. TERMS AND CONDITIONS

- Bids must be submitted in two envelopes mentioning Technical & Financial Proposal on the top of the envelope. The envelope should be sealed & signed.
- All the pages of the RFQ must be signed by the authorized representative of the bidder and filled in where applicable.
- Award finalization and subsequent actions: BURO Health Care Foundation will award
  the Contract to the Bidder whose offer is found to be substantially responsive who has
  offered a technically suitable proposal & whose quoted price is within the acceptable
  limit of BURO Health Care Foundation and who has expertise and experience in this job.
  After the selection of the Bidder, the Bidder will be supposed to maintain close contact
  with the client to sort out details of the works to be undertaken.
- BURO Health Care Foundation reserves the right to accept or reject any or all the Bidder without assigning any reason whatsoever.
- In case of any error detected in the Bill of Quantities or in other documents at any time, BURO Health Care Foundation reserves the right to rectify such error.
- BURO Health Care Foundation reserves all the rights to modify, remove, or add items
  from the Tender specification mentioned in this Tender schedule even after the
  submission of the bids.
- The detailed specifications, terms, and conditions are incorporated in this RFQ.
- BURO Health Care Foundation is not bound to accept the lowest price.
- For the purpose of the warranty period, work completion time will be counted from the date of installation, testing, and commissioning.
- No RFQ document will be issued/received by mail.
- The selected Bidder must complete the work within the time stipulated in the work order.
   Penalty on total quoted value 0.5% per day may be imposed for delay in completion of work.
- RFQ offer may be rejected for any one of the reasons listed herein. The decision of the BURO Health Care Foundation will be final in this regard:
  - a) Failure to submit RFO before the specified closing time.
  - b) All or any pages of the RFO document are not signed and sealed by the Bidder.
  - c) Failure to comply with the Specifications annexed herewith.
  - d) Any false statement or evidence of fraud.
  - e) Failure to comply with all the instructions of the RFQ.
  - f) Any alteration in the RFQ.
  - g) Any discrepancy, overwriting, erasing, ambiguity, or omission in quoting rate and in furnishing the RFQ document.

- The client may require the Bidder to supply the equipment partially and periodically as and when required.

### • WORK COMPLETION TIME:

Product Delivery and Project Completion time within 45 days after issuing Work Order.

### • QUALITY ASSURANCE:

The Bidder shall comply with the technical specifications as mentioned in the RFQ Schedule.

### 02. QUALIFICATION CRITERIA

- The bidder shall have a minimum of Five (05) years of overall experience in the supply of goods and related services.
- The bidder shall be a certified partner/distributor of the IT peripherals being supplied under the contract. Distributorship/partnership Certificates should be accompanied by an RFQ document
- The bidder should be a Certified Partner.
- The bidder must have experience of at least five similar product deployments (single job/tender) and should furnish a certificate/work order of completion.
- Products supplied under this contract Manufacturer's Country of Origin and Warranty Certificate must be certified by the Manufacturer otherwise the Bidder will be technically disqualified.
- Bidder must submit CVs of technical resources (Certified Professional) with a responsibility matrix.
- Active product Warranty information with Manufacturer's Part No. either in documents/Website should be provided by Bidder.
- All appliances must have Three year warranty starting from completion of implementation and GO LIVE.

### 04. PAPERS & DOCUMENTS TO BE SUBMITTED

- Up-to-date Trade License
- Up-to-date VAT certificate
- Up-to-date TIN certificate
- Certificate of Incorporation
- NID Card copy of Signatory.
- Declaration of Non Blacklist.

### 05. WARRANTY & AFTER SALES SERVICE

- The bidder should provide Three-years full warranty from the date of installation.
- Service/Support should be ensured for 365 x 24x7 within Two (02) Hours either physically or via remote access.

### 06. PRICE

- The bidder shall submit price quotations in the prescribed format but you can add rows as your requirement. Prices must remain valid for 90 days. The client may request for extension of the price validity.
- Prices must be quoted both in figures & in words. If there is any discrepancy between the price in the figure & the price in words, the latter will prevail.
- BURO Health Care Foundation reserves the authority to rectify any computation error in the price quotation of the bidders.
- The prices shall include all Taxes. The client shall deduct VAT & income Tax as per Govt. rule while making payment.

### 07. PAYMENT & SECURITY

- While making payment, 90% payment of quoted value will be issued within 30 days after Installation & commissioning. Rest 10% will issue after 06 months.
- VAT & income TAX will be deducted at source as per Govt. rule during making payment.
